### Synopsis of the main points

- Official output data in NACE 2 from Eurostat are released for 1995-2015.
- Official labour data in NACE 2 from Eurostat are released for 2008-2015.
- Official capital data in NACE 2 from Eurostat are not available.
- Gross output and intermediate input prices are neither available from Eurostat nor the OECD STAN database.
- New LFS and SES data for the years 2008-2015 are taken into account to compute labour services. Linkages to labour services from prior releases are not possible because the country was not released prior to 2017.
- Growth accounts are not calculated due to missing capital data.
